Fuel Adjustment – Monthly Update March 2026

What is the rate? How does it work?

The average price is calculated by Brink's using the average daily volume weighted retail price, including taxes, of diesel in Canada. This is reported by **Kalibrate**, a company that provides data on Canada's retail petroleum industry. Customers will see a fuel adjustment charge on their monthly invoice.

Does it impact all Customers?

The Fuel Adjustment will apply to all new customers and all existing customers upon renewal. Exceptions could apply. This charge is a percentage of the customers' total invoice and adjusted monthly based on changes in the average market price of diesel in Canada.

The current daily average price of Diesel is \$1.61

Accordingly, the Fuel Surcharge for March 2026 will be 25.5%. This will be reviewed again on March 15, 2026 based on the 4-week period ending March 14, 2026

Ajustement de carburant - Mise à jour mensuel mars 2026

Quel est le taux? Comment fonctionne-t-il?

Le prix moyen est calculé par Brink's en fonction de **la moyenne pondérée du volume mensuel du prix de détail du diesel au Canada, taxes comprises**. Ce prix de détail est établi par **Kalibrate**, une société qui fournit des données sur l'industrie canadienne du pétrole au détail. Les frais d'ajustement de carburant figureront sur la facture mensuelle des clients.

Quel sera l'impact sur les clients?

L'ajustement de carburant s'appliquera à tous les nouveaux clients ainsi qu'aux clients existants lors du renouvellement. Des exceptions pourraient s'appliquer. Cet ajustement est un pourcentage de la facture totale du client, établi mensuellement en fonction des variations du prix moyen du marché du diesel au Canada.

Le prix moyen actuel mensuel est de 1.61\$ le litre

Par conséquent, la surcharge pour le carburant du mois de mars 2026 sera de **25.5%**. Ceci sera réexaminé le 15 mars basé sur la période de 4 semaines se terminant le 14 mars.
