Brink’s Canada Fuel Surcharge
– Brinks Global Service Low Value Parcel/FedEx

The grid below is effective to all customers as of April 1, 2022.
The fuel surcharge effective April 1, 2025 will be 18.00%.

Calculation of Fuel Surcharge

Brink’s customers will have their fuel surcharge included on their invoice. Brink’s uses an index-based surcharge that is adjusted monthly. The surcharge changes will be effective on the first day of each month. The surcharge will be based on the fuel surcharge as reported by Fedex less 9.5%.

FedEx uses the rounded average of the Canadian diesel retail price for a litre of diesel fuel published by Natural Resources Canada.

There are many factors influencing the price of fuel in Canada. Fuel is a considerable variable cost in transportation services and a fuel surcharge is used to help manage volatility in prices

The fuel surcharge is reviewed monthly on the 1st of each month and will be reported on Brinks.ca approximately two weeks before the surcharge is in effect. Effective dates are the first day of every month
